  Michael Bakker has made arrangements to me the minor victim for sex for a second time. This is to occur this coming Wednesday night on 03/17/10.

  - In this jurisdiction, it would take us two weeks to obtain a subpoena for the information to prove Indecent Solicitation. We are trying to locate and arrest this suspect before any harm comes to the parties involved. We need this information to complete the search warrant process for his home. I promise to comply with a subpoena for your records after the fact of receiving this information.
- 5. What specific information in Face Books possession related to the emergency are you seeking to receive on an emergency basis? We are seeking any and all subscriber information, IP at start up, Last log in IP for the last 7 days, All comments and mail sent, received and deleted between these dates and any email accounts associated with this Facebook account; 13380007. 6. Please explain/describe how the information you request will assist in averting the threatened death or serious physical injury.

I will then contact the ISP for the IP information. I will in turn optain the IP information to locate the suspect and prove this criminal act to the DuPage County States Attorney's office. Therefore, the other IP's he has been using can be tracked.
